

ORDINANCE NO. 7890

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE TO THE FAMILY OF THE LATE P/S INSP. WILHELMINO C. TORRES, APPROPRIATING FUNDS THEREFOR.

Be it ordained by the City Council of Manila, **THAT:**

SECTION 1. The amount of TWENTY THOUSAND PESOS (P20,000.00) is hereby appropriated out of the funds existing in the City Treasury, not otherwise appropriated, to be made available for the grant of financial assistance to the family of the late P/S INSP. WILHELMINO C. TORRES who died in line of duty on August 18, 1994, while responding to an emergency incident.

SEC. 2. This Ordinance shall take effect immediately upon its approval.

Repassed with modification by the City Council of Manila at its regular session today, September 26, 1995.


