

AN ORDINANCE AUTHORIZING THE ACQUISITION BY NEGOTIATION OF CERTAIN PARCELS OF LAND LOCATED ALONG SOLIS STREET NEAR JUAN LUNA STREET IN THE SECOND DISTRICT OF MANILA WITH AN APPROXIMATE AGGREGATE AREA OF 3,979.10 SQUARE METERS AND COVERED BY TCT NOS. 71541, 71548, 24423, 71544, 71546 TO BE UTILIZED AS SCHOOL SITE FOR THE FRANCISCO BENITEZ ELEMENTARY SCHOOL OR INITIATE EXPROPRIATION PROCEEDINGS.

Be it ORDAINED by the City Council of Manila, that:

SECTION 1. His Honor, the Mayor, is hereby authorized to acquire by negotiation certain parcels of land located along Solis Street near Juan Luna Street in the Second District of Manila with an approximate aggregate area of 3,979.10 square meters and covered by TCT Nos. 71541, 71548, 24423, 71544, 71546 to be utilized as school site for the Francisco Benitez Elementary School or to initiate expropriation proceedings.


SEC. 2. An amount not to exceed the current fair market value, prevailing in the area appraised in accordance with the requirements of existing laws, rules and regulations, of the property to be acquired, or so much thereof as may be necessary for the purpose, shall be allocated out of the Special Education Fund of the City to defray the cost of acquisition of the above-mentioned parcels of land.


SEC. 3. This Ordinance shall take effect immediately.
