

AN ORDINANCE APPROPRIATING THE AMOUNT OF THREE HUNDRED SEVENTY FIVE THOUSAND AND THREE HUNDRED EIGHTEEN PESOS (P375,318.00) FOR THE PURCHASE OF TWO (2) SETS OF COMPUTER EQUIPMENT, SPECIFICALLY A PERSONAL COMPUTER, SCANNER, LASER PRINTER, AND ALL ACCESSORIES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. It is a declared policy of the City Government of Manila to render efficient and expeditious service to the public, especially concerning the release and research of public records.

SEC. 2. Pursuant to the above-declared policy, a system of releasing public records, thru the use of the aforementioned computer equipment such as personal computers, scanners and a laser printer, will enhance efficient public service.

SEC. 3. Records covered by the system shall include, but not be limited to the following documents:

- a. Proposed/Approved Ordinances
- b. Proposed/Adopted Resolutions

SEC. 4. The Records Section of the City Council shall be responsible for the promulgation of necessary guidelines, rules and regulations necessary for the implementation of this Ordinance.


SEC. 5. The amount of THREE HUNDRED SEVENTY FIVE THOUSAND AND THREE HUNDRED EIGHTEEN PESOS (P375,318.00) is hereby appropriated for the purchase of two (2) sets of computer equipment, including all accessories mentioned in Sec. 2 hereof.


SEC. 6. This Ordinance shall take effect upon approval.
