AN ORDINANCE RENAMING THE GAGALANGIN HEALTH CENTER LOCATED IN TONDO, MANILA TO ATANG DE LA RAMA HEALTH CENTER.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The Gagalangin Health Center in Tondo, Manila is hereby renamed Atang de la Rama Health Center.


SEC. 2. The City Engineer is hereby directed to install or cause the installation of the corresponding signboard in said health center.


SEC. 3. Effectivity Clause - This Ordinance shall take effect upon its approval.
