

ORDINANCE NO. 7903

AN ORDINANCE DECLARING THE SECOND WEEK OF MARCH OF EVERY YEAR AS "LINGGO NG KABABAIHAN" IN THE CITY OF MANILA.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. It is hereby declared the policy of the City Government to give recognition to women and underscore their role in nation-building by providing them a special week of acknowledgment.

SEC. 2. Pursuant thereto, the Second Week of March of every year is hereby declared as "Linggo ng Kababaihan" in the City of Manila.

SEC. 3. The Office of the City Mayor and all other offices pertinent for the purpose of Section 2 hereof shall conduct programs specially intended to give emphasis on the role of women in nation-building which shall include, but not be limited to, conducting seminars and/or symposia, essay writing contest, selection of outstanding women in various fields and welfare projects for unemployed women.


SEC. 4. The amount of One Hundred Thousand Pesos (P100,000.00) or so much thereof as may be needed for the purpose shall be appropriated into the annual budget of the City of Manila under the appropriations outlay of the Office of the Mayor.


SEC. 5. This Ordinance shall take effect upon approval.
