

ORDINANCE NO. 7909

AN ORDINANCE RENAMING CONCEPCION STREET FROM TAFT AVENUE TO THE FOOT OF AYALA BRIDGE NATIVIDAD ALMEDA-LOPEZ STREET.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Concepcion Street from Taft Avenue to the foot of Ayala Bridge is hereby renamed NATIVIDAD ALMEDA-LOPEZ STREET.

SEC. 2. The City Engineer is accordingly directed to replace or cause the corresponding replacement of the present signs installed in strategic places thereat, as follows:

NATIVIDAD ALMEDA-LOPEZ
(formerly Concepcion St.)


SEC. 3. Copies of this Ordinance shall be furnished the Office of the President of the Republic of the Philippines, the Representative of the 5th Legislative District of Manila and the Philippine Postal Corporation.


SEC. 4. This Ordinance shall take effect upon its approval.




