

ORDINANCE NO. *7911*

AN ORDINANCE AUTHORIZING HIS HONOR, THE MAYOR, TO NEGOTIATE FOR THE ACQUISITION, EITHER THROUGH NEGOTIATION OR EXPROPRIATION, OF CERTAIN PARCELS OF RESIDENTIAL LAND WITH AN AGGREGATE AREA OF 9,853.70 SQUARE METERS, LOCATED AT STA. CRUZ, MANILA, FORMING PART OF, OR COMPRISING THE AREA KNOWN AS THE TAMBUNTING ESTATE, AND COVERED BY TCT NOS. 122451, 122452, 122453, 122454, 122455, 122456, 122458, 122459 and 133514 FOR RESALE AT AN APPROPRIATE PRICE TO THE ACTUAL OCCUPANTS THEREAT UNDER THE HOME-FOR-THE-HOMELESS PROGRAM OF THE CITY GOVERNMENT, AND APPROPRIATING FUNDS NEEDED THEREFOR, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. His Honor, the Mayor, is hereby authorized to negotiate for the acquisition, either by negotiation or expropriation of certain parcels of residential land with an aggregate area of 9,853.70 square meters, located at Sta. Cruz, Manila, forming part of, or comprising the area known as the Tambunting Estate, and covered by TCT Nos. 122451, 122452, 122453, 122454, 122455, 122456, 122458, 122459 and 133514 for resale at an appropriate price of the actual occupants thereof, under the "Home-for-the-Homeless" program of the City Government.

The amount necessary for the expropriation may be taken out of any available funds of the City of Manila.


SEC. 2. This project, when undertaken, shall be under the supervision of the Urban Settlements Office, in coordination with, and direct participation of, the representatives of the actual and bona fide residents thereat.


SEC. 3. This Ordinance shall take effect upon its approval.
