

ORDINANCE NO. 7914

AN ORDINANCE AMENDING SECTION 2-A OF ORDINANCE NO. 7755 AND SECTION 2 OF ORDINANCE NO. 7871 BY INCLUDING THEREIN THE TRICYCLE TERMINAL AND THE ROUTE LINE OF ASUNCION, SUCOR, PAROLA, TONDO TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (ASPTTODA), INC.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Section 2-a of Ordinance No. 7755 (Tricycle Terminals) is hereby amended by adding another Number, after No. 25, to be known as No. 26, to be read as follows:

"26. Asuncion, Sucor, Parola, Tondo Tricycle Operators and Drivers Association (ASPTTODA), Inc."

SEC. 2. Section 2 of Ordinance No. 7871 is hereby amended by adding another number after 29, to be known as No. 30, to be read as follows:

Association	Route	R.M.C.
30. Asuncion, Sucor, Parola, Tondo Tricycle Operators and Drivers Association (ASPTTODA), Inc.	Juan de Moriones-Parola Compound	100 units

The authorized route/line of operation of the association shall be J. de Moriones (loading and unloading)-Clavel/Lavezares-Del Pan and C. M. Recto Avenue-Parola Compound.


The return trip shall be Parola Compound-Del Pan Sub Way- San Miguel Glass Plant - Muelle dela Industria - Del Pan Street - Clavel - Lavezares to Juan de Moriones.


SEC. 3. This Ordinance shall take effect upon approval.

Enacted by the City Council of Manila at its regular session today, October 22, 1996.




