

ORDINANCE NO. 7922

AN ORDINANCE AMENDING SECTION 2.A OF ORDINANCE NO. 7755 BY INCLUDING THEREIN THE JEEPNEY TERMINAL OF THE PUNTA TRANSPORT SERVICE COOPERATIVE, INC.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Section 2.a of Ordinance No. 7755 (Jeepney Terminals) is hereby amended by adding another number, after No. 29, to be known as No. 30, to be read as follows:

30. Punta Transport Service Cooperative, Inc.


- a. New Panaderos St. near the corner of Castaneda St.
- b. J. Posadas St. near the corner of Daguisonan St.


SEC. 2. This Ordinance shall take effect upon its approval.


