

ORDINANCE NO. 7925

AN ORDINANCE AUTHORIZING THE EXPROPRIATION BY THE CITY GOVERNMENT OF THAT CERTAIN PARCEL OF LAND WITH AN AREA OF 4,008.90 SQUARE METERS, MORE OR LESS, SITUATED IN THE SECOND DISTRICT OF MANILA, AND COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 122060 REGISTERED IN THE NAME OF FLORENCIO REYES, ET. AL., FOR USE AS SCHOOL SITE OF THE PRESIDENT SERGIO OSMENA HIGH SCHOOL, UTILIZING FOR THE PURPOSE THE AMOUNT OF THIRTY-EIGHT MILLION TWO HUNDRED NINETY FIVE THOUSAND NINE HUNDRED TEN PESOS (P38,295,910.00) SET ASIDE BY THE CITY SCHOOL BOARD.

Be it ordained by the City Council of Manila, **THAT:**


**SECTION 1.** The City Government of Manila is hereby authorized to expropriate that certain parcel of land with an area of 4,008.90 square meters, more or less, situated in the Second District of Manila, and covered by Transfer Certificate of Title No. 122060 registered in the name of Florencio Reyes, et. al., for use as school site of the President Sergio Osmeña High School, utilizing for the purpose the amount of THIRTY-EIGHT MILLION TWO HUNDRED NINETY FIVE THOUSAND NINE HUNDRED TEN PESOS (P38,295.910.00) set aside by the City School Board.


**SEC. 2.** This Ordinance shall take effect upon approval.

Enacted by the City Council of Manila at its regular session today, May 27, 1997.


