

ORDINANCE NO. 7929

AN ORDINANCE PROHIBITING THE SHOWING OF MOVIE TRAILERS OF FILMS WITH R (RESTRICTED) AND PG (PARENTAL GUIDANCE) CLASSIFICATIONS DURING INTERMISSIONS/BREAKS ON THE DURATION OF PLAYDATES OF A GP (GENERAL PATRONAGE) MOVIE/S IN THE CITY OF MANILA, PROVIDING PENALTIES THEREOF.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. It shall be unlawful for any theater owner/operator to show movie trailers of films with the R (Restricted) and PG (Parental Guidance) classifications during the intermissions/breaks on the duration of playdates of a GP (General Patronage) movie/s in the City of Manila.

1.1 Definitions

- a. Restricted or R - a classification of motion picture admission which is limited to adults. Adults are persons eighteen (18) years of age or over.
- b. Parental Guidance or PG - a classification of motion picture cautioning parents on the delicate contents of the film and the need for parental guidance in its appreciation.
- c. General Patronage or GP - a classification of motion picture, admission to which is open to persons of all ages.


SEC. 2. Penalty. Violation of this Ordinance shall be punishable by a fine of FIVE THOUSAND PESOS (P5,000.00) or imprisonment of not more than thirty (30) days, or both, at the discretion of the court. In case of juridical person the penalty shall be imposed on the President or General Manager of such establishment.


SEC. 3. This Ordinance shall take effect upon its approval.


