

ORDINANCE NO. 7936

AN ORDINANCE FURTHER AMENDING SECTION 2-A OF ORDINANCE NO. 7755 (TRICYCLE TERMINALS) AS AMENDED, AND SECTION 2 (ITEM NO. 8) OF ORDINANCE NO. 7871 AS AMENDED, BY INCLUDING THEREIN THE TRICYCLE TERMINAL OF THE BLUMENTRITT, ESPANA, CALABASH TRICYCLE OPERATORS AND DRIVERS ASSOCIATION (BLUESCATODA), INC. AND INCREASING ITS ALLOCATED NUMBER OF UNITS FROM 25 TO 50 UNITS, RESPECTIVELY.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Sec. 2.a of Ordinance No. 7755 (Tricycle Terminals) as amended, is hereby further amended by adding another number, after No. 27, to be known as No. 28, to be read as follows:

"28. Blumentritt, Espana, Calabash Tricycle Operators and Drivers Association (BLUESCATODA), Inc.

- A. Espana cor. Blumentritt Ext.
- B. Calabash Road cor. Firmeza Ext."

SEC. 2. Sec. 2 (Item No. 8) of Ordinance No. 7871, as amended, is hereby amended by increasing the number of units allocated to the BLUESCATODA, to be read as follows:




SEC. 3. This Ordinance shall take effect upon its approval.
