

ORDINANCE NO. *7943*

AN ORDINANCE REQUIRING OWNERS OF DISCO HOUSES, MUSIC BARS, LOUNGES, RESTAURANTS, MOVIE HOUSES, THEATERS, INSTITUTIONAL BUILDINGS, EDUCATIONAL OCCUPANCIES OR ESTABLISHMENTS, MIXED OCCUPANCIES, AND BUSINESS OCCUPANCIES TO DISPLAY THEIR FLOOR PLANS IN CONSPICUOUS PLACES WITHIN THEIR RESPECTIVE ESTABLISHMENTS.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy. It shall be the Policy of the City of Manila to ensure public safety and the best interest of its constituents.

SEC. 2. Pursuant to the above policy, it is hereby required that owners of buildings and structures mentioned in the title of this Ordinance to display their floor plans in conspicuous places within their respective establishments.

SEC. 3. Penalty Clause - Any person found violating this Ordinance shall suffer a fine of Five Thousand Pesos (P5,000.00) or two (2) months imprisonment, or both, upon the discretion of the Court; if the offender is a Firm, Company, Association, Corporation or Partnership, the President, General Manager, Chairman of the Board of Directors or Managing Partner shall be held liable for the penalty or penalties herein provided. Subsequent violation shall be a ground for the outright cancellation or revocation of its permit to operate.


SEC. 4. This Ordinance shall take effect upon its approval.
