

ORDINANCE NO. 7945

AN ORDINANCE RENAMING ROAD 3 IN BARANGAY NO. 899, ZONE NO. 100, IN THE 6TH DISTRICT OF MANILA, TO AMPARO VILLAMOR STREET.

WHEREAS, on July 30, 1965, the Barangay Council of Barangay 899, Zone 100 in the 6th District of Manila passed Resolution No. 95-026, urging the City Council to rename Road 3, located thereat to Amparo Villamor Street;

WHEREAS, the aforesaid Resolution cited the fact that the territorial jurisdiction of Barangay No. 899, Zone No. 100 consisted of Road 1, Road 2 and Road 3, and the original name of the entire place being Barrio Puso;

WHEREAS, by virtue of Presidential Proclamation No. 818 of the late President Carlos P. Garcia, the aforementioned area was declared as relocation site for the victims of typhoon Lucille which inundated the City on May 28, 1960;

WHEREAS, it was then First Lady Leonila Garcia who solicited funds for the construction of 100 houses for the victims of the typhoon;

WHEREAS, then Secretary Amparo Villamor of the Department of Social Welfare (DSW) assisted the First Lady, in the study and evaluation of the plans for this project and played an active role in the realization of the construction of the housing units and the subsequent relocation of the typhoon victims; NOW, THEREFORE, be it

ORDAINED by the City Council of Manila, THAT:

SECTION 1. Road 3 in Barangay 899, Zone 100, in the 6th District of Manila is hereby renamed Amparo Villamor Street.

SEC. 2. The City Engineer is hereby directed to replace or cause the replacement of the present street signs installed at strategic places thereat, as follows:

AMPARO VILLAMOR STREET  
(ROAD 3)




