

ORDINANCE NO. *7949*

AN ORDINANCE AUTHORIZING HIS HONOR, THE MAYOR TO NEGOTIATE FOR THE ACQUISITION EITHER BY PURCHASE, EXPROPRIATION OR OTHER LEGAL MEANS, OF THAT PARCEL OF LAND SITUATED AT GABRIELA STREET, DAGUPAN, TONDO, MANILA COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 227512 FOR RESALE AT COST TO BONA FIDE OCCUPANTS THEREAT.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. His Honor, the Mayor, is hereby authorized to negotiate for the acquisition either by purchase, expropriation or other legal means, of that parcel of land situated at Gabriela Street, Dagupan, Tondo, Manila with an area of One Thousand One Hundred Eighty Two Square Meters and Twenty Square Decimeters (1,182.20) covered by Transfer Certificate of Title No. 227512 and registered in the names of the heirs of the late Irene Ombac.

SEC. 2. The aforementioned parcel of land when acquired shall be subdivided and resold to qualified bona fide occupants thereat, particularly the registered members of the Gabriela Neighborhood Association and which subdivision shall be limited to the areas presently occupied by each member.

SEC. 3. The City Mayor may utilize for this purpose any available funds in the City Treasury or avail of other financing facilities from other government agencies.

SEC. 4. This Ordinance shall take effect upon its approval.
