ORDINANCE NO. _2953

AN ORDENANCE ESTABLISHING THE SEAWALL DEVELOPMENT AND SUNSET PARK PROJECT (SDSPP) IN THE CITY OF MANILA AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. There is hereby created and established the SEAWALL DEVELOPMENT AND SUNSET PARK PROJECT (SDSPP) in the City of Manila along Roxas Boulevard from the U.S. Embassy to Quirino Avenue in Malate, to develop and promote the site as a tourist attraction, by providing for the construction, operation, and maintenance of adequate tourism infrastructure projects and/or facilities relative to the establishment of a Sunset Park on the subject premises.

- SEC. 2. In line with the general objective of this Ordinance, the development of the first one hundred (100) meters by twenty eight (28) meters, more or less of the seawall easement into a mini-park with a multi-purpose tourism shed, cafe, and parking lot from the Balikbayan Tourist Protection Station of the PNP Southwards by the Philippine Amusement and Gaming Corporation (PAGCOR) is hereby authorized, subject to a lease/concession agreement to be entered into between PAGCOR and the City Government.
- SEC. 3. The City Mayor is hereby mandated to formulate the corresponding guidelines rules and regulations which are necessary, proper and appropriate, to ensure that the provisions of this Ordinance are carried out and implemented in pursuance of its goals and objectives, and shall for such purpose, be authorized to enter into an agreement or joint venture with the public or private sector or non-governmental organizations, in accordance with Articles 30, 66 and 70 of the Rules and Regulations implementing the Local Government Code of 1991 and all applicable laws or ordinances relative thereto.

SEC. 4. This Ordinance shall take effect immediately upon its approval.
