

ORDINANCE NO. 7959

AN ORDINANCE EXPROPRIATING CERTAIN PARCELS OF LAND OR PORTIONS THEREOF, KNOWN AS LOT NOS. 5, 6 AND 7, BLOCK 29, LRC RECORD NO. 11546 AND 4004 AND COVERED BY TCT NOS. 198223, 109990 AND 109991 EACH WITH AN AREA OF FOUR HUNDRED SEVENTY FIVE (475) SQ. METERS, MORE OR LESS, OR A TOTAL AREA OF ONE THOUSAND FOUR HUNDRED TWENTY FIVE (1,425) SQ. METERS LOCATED AT CORNER GOV. FORBES AND MARIA CLARA STREETS IN THE THIRD DISTRICT OF MANILA, TO BE SUBDIVIDED AND RESOLD ON INSTALLMENT BASIS NOT EXCEEDING TWENTY (20) YEARS TO QUALIFIED AND BONA FIDE RESIDENTS/OCCUPANTS THEREAT.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The expropriation of those parcels of land or portions thereof, known as lot Nos. 5, 6 and 7, Block 29 LRC Record No. 11546 and 4004 and covered by TCT Nos. 198223, 109990 and 109991 each with an area of Four Hundred Seventy Five (475) Sq. Meters, more or less, or a total area of One Thousand Four Hundred Twenty Five (1,425) Sq. Meters located at corner Gov. Forbes and Maria Clara Streets in the Third District of Manila is hereby authorized.

SEC. 2. The aforementioned parcels of land, when acquired, shall be subdivided and resold to qualified and bona fide residents/occupants thereat, on installment basis not exceeding twenty (20) years.

SEC. 3. The amount of Ten Million Two Hundred Fifty Thousand Pesos (P10,250,000.00) or so much thereof as may be necessary is hereby appropriated out of any unappropriated funds existing in the City Treasury for the acquisition of subject parcels of land.

SEC. 4. This Ordinance shall take effect upon its approval.
