

ORDINANCE NO. 7965

AN ORDINANCE CREATING EIGHT (8) ADDITIONAL NURSE VI POSITIONS IN THE MANILA HEALTH DEPARTMENT, APPROPRIATING THE NECESSARY FUNDS THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy. - It is hereby declared the policy of the City of Manila to continuously upgrade the health and medical extension services in the different health centers and public schools in the City.

SEC. 2. Pursuant to this policy, there is hereby created eight (8) additional Nurse VI positions in the Division of Nursing Services of the Manila Health Department. PROVIDED HOWEVER, That the four (4) Nurse V positions shall be abolished after the incumbents thereof shall have been promoted to the newly created Nurse VI positions.

SEC. 3. The amount needed or so much thereof as may be necessary for the payment of salaries, allowances and mandatory contributions for the created positions shall be made available from the salary savings of the Manila Health Department for Calendar Year 1999.




SEC. 5. Effectivity Clause. - This Ordinance shall take effect upon its approval.


