

ORDINANCE NO. 7967

AN ORDINANCE EXPROPRIATING CERTAIN PARCELS OF LAND SITUATED AT BARANGAY 527, ZONE 52, SAMPALOC, MANILA PARTICULARLY LOT NOS. 72, 73 AND 74, BLOCK 39 OF HACIENDA LEGARDA COVERED BY TCT NOS. 213553, 213554 AND 213555 AND OWNED BY MA. LUISA T. DEL ROSARIO ET. AL. TO BE RESOLD ON INSTALLMENT BASIS NOT EXCEEDING TWENTY (20) YEARS TO QUALIFIED BONA FIDE TENANTS/OCCUPANTS THEREAT PURSUANT TO THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The expropriation of certain parcels of land situated at Barangay 527, Zone 52, Sampaloc, Manila particularly Lot Nos. 72, 73 and 74, Block 39 of Hacienda Legarda covered by TCT Nos. 213553, 213554 and 213555 and owned by Ma. Luisa T. del Rosario et. al. is hereby authorized pursuant to the Land-for-the-Landless Program of the City of Manila.

SEC. 2. The aforementioned parcels of land, when acquired, shall be resold to qualified bona fide tenants/occupants thereat, on installment basis not exceeding twenty (20) years.


SEC. 3. The Mayor may avail of or tap any available funds of the City or other financing facilities from other government agencies.


SEC. 4. This Ordinance shall take effect upon its approval.


