ORDINANCE NO.

AN ORDINANCE DECLARING JUAN LUNA STREET FROM PLAZA LORENZO RUIZ TO STA. ELENA STREET AS ONE (1) WAY TRAFFIC STREET FROM 5:00 A.M. TO 8:00 P.M. AND AS TWO (2) WAY TRAFFIC STREET FROM 8:00 P.M. TO 5:00 A.M.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Juan Luna Street from Plaza Lorenzo Ruiz to Sta. Elena Street is hereby declared as one (1) way traffic street from 5:00 a.m. to 8;00 p.m. and as two (2) way traffic street from 8:00 p.m. to 5:00 a.m.

- SEC. 2. Penalty Clause. Any person found violating the provisions of this Ordinance shall, upon conviction, be punished by fine not exceeding one hundred pesos (\$100.00).
- SEC. 3. The Chief of the Traffic Management District is hereby directed to install the traffic signs in strategic portions of said street indicating therein the Ordinance number and the penalty to be imposed in case of violation.
- SEC. 4. Separability Clause. In case any provision of this Ordinance be declared invalid or unconstitutional, the validity of the other provisions shall not be affected thereby.
- SEC. 5. Repealing Clause. All Ordinances inconsistent herewith are hereby repealed.

SEC. 6. Effectivity Clause. - This Ordinance shall take effect upon its approval.
