

ORDINANCE NO. 7975

AN ORDINANCE EXPROPRIATING THAT CERTAIN PARCEL OF LAND OWNED BY GUIDOTE MERCANTILE CORPORATION UNDER TCT NOS. 76220, 194782, 120802, 241957, 94769 AND 39078 MEASURING FOUR THOUSAND SIX HUNDRED FORTY THREE AND 70/100 (4,643.70) SQUARE METERS, MORE OR LESS, LOCATED ALONG LEGARDA STREET, MANILA, AND ADJACENT TO THE OLD AND NEW SAMPALOC MARKETS, TO BE USED AS RELOCATION SITE OF THE STALLHOLDERS OF SAID MARKETS, WHO WILL BE DISPLACED BY THE CONSTRUCTION OF THE MRT LINE 2 PROJECT; APPROPRIATING THIRTY MILLION (P30,000,000.00) PESOS OR SO MUCH THEREOF, AS MAY BE NECESSARY, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The expropriation of a parcel of land measuring four thousand six hundred forty three and 70/100 (4,643.70) square meters, more or less, located along Legarda Street, Manila, adjacent to the Old and New Sampaloc Markets and owned by Guidote Mercantile Corporation under TCT Nos. 76220, 194782, 120802, 241957, 94769 and 39078 in the Registry of Deeds for the City of Manila, to be used as relocation site of stallholders to be displaced by the construction of the MRT Line 2 Project, is hereby authorized.

SEC. 2. The amount of Thirty Million (P30,000,000.00) Pesos or so much thereof, as may be necessary to represent the fair market value is hereby appropriated.


SEC. 3. Upon acquisition of said property, the City Mayor shall undertake the necessary measures to relocate the stallholders of the Old and New Sampaloc Markets to the new site.


SEC. 4. This Ordinance shall take effect upon approval.


