

ORDINANCE NO. **7977**

AN ORDINANCE GRANTING RETIRED TEACHERS AND OTHER NON-TEACHING EMPLOYEES OF THE DIVISION OF CITY SCHOOLS OF MANILA, A MONTHLY OLD AGE SUSTENANCE ASSISTANCE (OASA) IN THE AMOUNT OF FIVE HUNDRED PESOS (P500.00) FOR LIFE, TO COMMENCE ON THEIR 70TH BIRTHDAY, APPROPRIATING THE AMOUNT OF SIX MILLION PESOS (P6,000,000.00), THEREFORE, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy. It is the policy of the City Government of Manila to give recognition to the distinguished and unparalleled services rendered by retired teachers and other non-teaching employees of the Division of City Schools of Manila, especially those who are already 70 years old and above.


SEC. 2. As an expression of gratitude and appreciation for their unselfish and invaluable services to the City in educating our youth, retired teachers and other non-teaching employees of the Division of City Schools, Manila are hereby granted an Old Age Sustenance Assistance (OASA) in the amount of FIVE HUNDRED PESOS (P500.00) per month for life, beginning on their 70th birthday, over and above whatever the retirees have received and are still receiving as retirement benefits from the Government Service Insurance System (GSIS).


SEC. 3. There is hereby appropriated the amount of SIX MILLION PESOS (P6,000,000.00) out of the General Fund in the City Treasury as certified by the City Treasurer, for the payment of the above-mentioned allowance for the fiscal year 1999. Thereafter, the amount as may be necessary for the payment of said benefit for the succeeding years shall be included in the annual appropriation outlay of the Division of City Schools under Personal Services (Other Benefits).


SEC. 4. This Ordinance shall take effect immediately upon approval.


