

ORDINANCE NO. 7981

AN ORDINANCE PROHIBITING THE UNLOADING AND STOCKPILING OF LOOSE GRAVEL AND SAND AND OTHER CONSTRUCTION MATERIALS ON CITY STREETS, SIDEWALKS, GUTTERS AND CURBS, AND REGULATING THE STORAGE PLACES IN SACKS OR BOXED-IN CONTAINERS.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The unloading and stockpiling of loose gravel and sand and other construction materials on City streets, sidewalks, gutters and curbs is hereby prohibited.

SEC. 2. Exemptions - The unloading and stockpiling of loose gravel and sand shall however, be allowed if stored in sacks or boxed-in containers in vacant lots designated by the barangay chairman: PROVIDED, That if the designated place is not yet available, loading and stockpiling shall be allowed upon issuance of a temporary permit by the City Engineer's Office: PROVIDED HOWEVER, That permit for stockpiling shall not exceed Three (3) Days.

SEC. 3. Penalty Clause - Any person found violating or infringing this Ordinance shall be punished by a fine of One Thousand Pesos (Php 1,000.00), or imprisonment of One (1) month or both such fine and imprisonment at the discretion of the court: PROVIDED, That if the violator or offender is a firm, company, association, corporation or partnership, its manager, president or chairman of the board of directors or managing partner shall suffer the fine of FIVE THOUSAND PESOS (Php 5,000.00), or imprisonment of Six (6) months or both such fine and imprisonment at the discretion of the court, as the case may be.

SEC. 4. Repealing Clause - Any Ordinance, rules and regulations in conflict and inconsistent herewith is hereby, in part or in whole, modified or repealed.


SEC. 5. Separability Clause - In case any provision of this Ordinance be declared invalid or unconstitutional, the validity of the other provisions shall not be affected thereby.


SEC. 6. Effectivity Clause - This Ordinance shall take effect upon its approval.


