

ORDINANCE NO. 7987

AN ORDINANCE AUTHORIZING THE IMPLEMENTATION OF RELEVANT PROVISIONS OF REPUBLIC ACT 7305, OTHERWISE KNOWN AS THE MAGNA CARTA OF PUBLIC HEALTH WORKERS, SO AS TO PROVIDE FOR RETIREMENT PAY, HAZARD ALLOWANCE, LONGEVITY PAY, AND OVERTIME PAY OF PUBLIC HEALTH WORKERS, IN THE MANILA HEALTH DEPARTMENT.

WHEREAS, R.A. 7305, otherwise known as the Magna Carta of Public Health Workers, and its implementing rules and regulations approved on April 17, 1992, has not been fully implemented in the Manila Health Department;

WHEREAS, in City Council Resolution adopted on May 2, 1994, then Mayor Alfredo S. Lim was urged to implement R.A. 7305 with the end in view, of standardizing the compensation and benefits of Public Health Workers in the Manila Health Department;

WHEREAS, despite such City Council Resolution, partial implementation was carried into effect providing only for the payment of subsistence and laundry allowances to Manila Public Health Workers: NOW, THEREFORE,

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The implementation of relevant provisions of the Magna Carta of Public Health Workers, otherwise known as R.A. 7305 so as to provide for retirement pay, hazard allowance, longevity pay, and overtime pay of Public Health Workers in the Manila Health Department is hereby authorized.




SEC. 3. Effectivity Clause.- This Ordinance shall take effect immediately upon its approval.


