

ORDINANCE NO. *7989*

AN ORDINANCE EXTENDING FINANCIAL ASSISTANCE, BY WAY OF ADDITIONAL RETIREMENT BENEFITS TO RETIRED MEMBERS OF THE THEN MANILA POLICE DEPARTMENT (NOW WESTERN POLICE DISTRICT), UNDER CERTAIN CONDITIONS, AND APPROPRIATING THE FUNDS NECESSARY THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. DECLARATION OF POLICY. - It is hereby declared the policy of the City Government of Manila to provide incentives to efficient and dedicated public servants and to honor retirees by extending financial benefits, including the retired (surviving) members of "Manila's Finest" for their exemplary service to the City and its people.

SEC. 2. COVERAGE. - Only surviving retired members of the then Manila Police Department, then Metropolitan Manila Police, now, Western Police District shall be entitled to the grant of financial assistance subject of this Ordinance: PROVIDED, That they shall meet the following requirements:

a) The retired member shall have received his/her initial appointment either as Patrolman, Detective or its equivalent, from the Manila Police Department of the City Government of Manila; and

b) The covered member shall have served in the then Manila Police Department, now Western Police District, for a period of not less than fifteen (15) years at the time of retirement or separation from police service.

SEC. 3. BENEFITS. - The financial benefit, referred to in Section 1 hereof, shall be a lump sum gratuity to be paid to every retired (surviving) officer or non-officer subject of the preceding section, in the amount of ONE HUNDRED THOUSAND PESOS (Php 100,000.00).


SEC. 4. The amount of SIXTY TWO MILLION FOUR HUNDRED THOUSAND PESOS (Php 62,400,000.00), or so much thereof, as may be necessary is hereby appropriated out of any unappropriated funds existing in the City Treasury to be made available for payment of subject financial assistance.


SEC. 5. EFFECTIVITY CLAUSE. - This Ordinance shall take effect upon its approval.


