

ORDINANCE NO. 7993

AN ORDINANCE AUTHORIZING HIS HONOR, THE CITY MAYOR TO CAUSE THE ACQUISITION, OF THAT CERTAIN PARCEL OF LAND SITUATED AT BAGONG LUPA (FORMERLY BASECO ISLAND) IN PORT AREA, MANILA, WITH AN AREA OF ONE HUNDRED TWENTY THOUSAND SQUARE METERS (120,000 sq.m.) OR (12 HECTARES) MORE OR LESS WHICH SHALL BE AWARDED TO THE ACTUAL BONA FIDE OCCUPANTS/TENANTS THEREAT, PURSUANT TO THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy. – It is hereby declared the policy of the City Government of Manila to adhere to the pertinent provisions of the Land-for-the-Landless Program and adopt concrete measures that will alleviate the living conditions of our less fortunate and homeless inhabitants and promote social equity and order, as enshrined in the fundamental law of the land.

SEC. 2. Pursuant to this policy, the City Mayor of Manila, is hereby authorized to cause the acquisition of that parcel of land situated in Bagong Lupa (formerly Baseco Island) in Port Area, Manila with an area of One Hundred Twenty Thousand square meters (120,000 sq.m.) or (12 hectares) more or less which shall be awarded to the bona fide occupants/tenants thereat, pursuant to the Land-for-the-Landless Program of the City.


SEC. 3. The Housing and Urban Development Board in coordination with the Urban Settlements Office shall take charge of the distribution/award or sale of the above subject property to bona fide tenants thereat, subject to existing policies and guidelines.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect upon its approval.


