

ORDINANCE NO. 7996

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 7718, BY INCREASING THE CHARGE OF TEN PESOS (Php 10.00), TO FIFTEEN PESOS (Php 15.00), FOR EVERY SET OF APPLICATION FORM SECURED BY EVERY APPLICANT IN ANY TRADE, BUSINESS AND OCCUPATION IN THE CITY OF MANILA.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Section 1 of Ordinance 7718 is hereby amended to read as follows:

"Section 1. There shall be imposed for every set of application form the amount of Fifteen Pesos (Php 15.00) secured by every applicant in any of the following categories:


- a.) Occupation or Calling Application Forms;
- b.) Mechanical Permit Application Forms;
- c.) Electrical Permit Application Forms;
- d.) Building Permit Application Forms; and
- e.) Any Trade or Business Application Form."


SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.


