

ORDINANCE NO. 7997

AN ORDINANCE APPROPRIATING FIVE HUNDRED THOUSAND PESOS (Php 500,000.00), FOR THE COMPLETION OF THE CONSTRUCTION OF THE BUILDING IN THE FOURTH DISTRICT OF MANILA, WHICH HOUSES THE MANILA DEPARTMENT OF SOCIAL WELFARE.

Be it ordained by the City Council of Manila, THAT:


SECTION 1. The amount of Five Hundred Thousand Pesos (Php 500,000.00), or so much thereof, as may be necessary, is hereby appropriated out of the general fund for the completion of the construction of the building in the Fourth District of Manila, which houses the Manila Department of Social Welfare.


SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.


