ORDINANCE NO. 8007

AN ORDINANCE GRANTING FINANCIAL ASSISTANCE IN THE AMOUNT OF FIFTY THOUSAND PESOS (Php 50,000.00) TO THE FAMILY OF THE LATE POLICE MAJOR JOSE TANZON PRING, IN APPRECIATION FOR HIS VALUABLE SERVICES RENDERED TO THE RESIDENTS OF MANILA, AS AN OFFICER AND MEMBER OF THE WESTERN POLICE DISTRICT FOR MORE THAN 25 YEARS.

WHEREAS, Police Major Jose Tanzon Pring is an officer and member of Manila's Finest who deserves to be recognized posthumously for the services he rendered to the organization and the Western Police District (WPD);

WHEREAS, serving for 25 years from October 1969 to December 1994 he received several awards, recognition, and citations bestowed upon him by the WPD;

WHEREAS, there is therefore good reason to keep in our memory the late P/Major Joe Pring whose bemedalled and colorful career as an officer whose achievements, continues to awe and earn the administration of the officers and men of the WPD: NOW, THEREFORE,

Be it Ordained by the City Council of Manila, THAT:

SECTION 1. A financial assistance in the amount of Fifty Thousand Pesos (Php 500,000.00) is hereby granted to the family of the late Police Major Jose Tanzon Pring in appreciation for his valuable services rendered to the residents of Manila, as an officer and member of the Western Police District for more than 25 years.

SEC. 2. Effectivity Clause. - This Ordinance shall take effect upon its approval.
