

ORDINANCE NO. 8013

AN ORDINANCE EXPROPRIATING THAT PARCEL OF LAND WITH AN AREA OF SEVEN HUNDRED THIRTY EIGHT SQUARE METERS AND NINETY SQUARE DECIMETERS (738.90), OWNED BY SALVACION B. RODRIGUEZ AND HERMINIA B. RODRIGUEZ, AND SITUATED AT DIZON ST., IN THE SECOND DISTRICT, CITY OF MANILA, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 132524, TO BE AWARDED TO QUALIFIED, ACTUAL AND BONA FIDE TENANTS OR OCCUPANTS THEREAT, ON INSTALLMENT BASIS, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA, AND SETTING ASIDE THE AMOUNT NEEDED THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The expropriation of that parcel of land with an area of Seven Hundred Thirty Eight Square Meters and Ninety Square Decimeters (738.90), owned by Salvacion B. Rodriguez and Herminia B. Rodriguez, situated at Dizon St., in the Second District, City of Manila, and covered by Transfer Certificate of Title No. 132524, is hereby authorized.

SEC. 2. The aforementioned parcel of land shall, upon acquisition, be resold at cost and on installment basis to qualified actual and bona fide tenants, or occupants thereat, under the Land-for-the-Landless Program of the City Government.


SEC. 3. The amount of P 1,500,000.00 is hereby set aside from the lump sum appropriation for acquisition of landed estates under the currently enforced budget as initial expense for the filing of the expropriation proceeding.


SEC. 4. Effectivity Clause. – This Ordinance shall take effect immediately upon its approval.


