

ORDINANCE NO. 8025

AN ORDINANCE CREATING CERTAIN PLANTILLA POSITIONS IN THE CITY COUNCIL OF MANILA, TO BE ASSIGNED TO THE STANDING COMMITTEES; REALIGNING A PORTION OF THE AMOUNT ALLOCATED FOR TERMINAL LEAVE PAY AND FOR EXPENSES FOR ATTENDANCE IN LOCAL/INTERNATIONAL CONFERENCES IN THE APPROPRIATIONS OUTLAY OF SAID OFFICE, UNDER BUDGET ORDINANCE NO. 8008; AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The creation of the following plantilla positions in the City Council of Manila to be assigned to the standing committees effective July 1, 2001, is hereby authorized, to wit:


SEC. 4. This Ordinance shall take effect upon approval.






