

N ORDINANCE GRANTING A MONTHLY ALLOWANCE OF TWO THOUSAND PESOS (PHP 2,000.00) EACH, TO PAROLE AND PROBATION OFFICERS AND PERSONNEL ASSIGNED IN THE SIX (6) PAROLE AND PROBATION OFFICES IN THE CITY OF MANILA; AND APPROPRIATING THE AMOUNT NEEDED THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. *Declaration of Policy.* – It is the declared policy of the City of Manila to assist National Government employees rendering essential services to the City of Manila and her constituents.

SEC. 2. Pursuant to this policy, a monthly allowance of TWO THOUSAND PESOS (Php 2,000.00) each, is hereby granted to the fifty (50) Parole and Probation Officers and Personnel effective January 2002, subject to existing guidelines on the matter.


SEC. 3. The amount of ONE MILLION TWO HUNDRED FIFTY THOUSAND PESOS (Php 1.25 M), or so much thereof, as may be necessary, is hereby appropriated out of any unappropriated funds existing in the City Treasury, to be made available for the purpose hereof: *PROVIDED*, That the aggregate amount needed to fund the payment for this benefit, shall thereafter be incorporated in the Annual Executive Budget of the City.


SEC. 4. *Effectivity Clause.* – This Ordinance shall take effect upon its approval.




