

ORDINANCE NO. 8036

AN ORDINANCE GRANTING A MONTHLY TRAVELING ALLOWANCE OF TWO THOUSAND FIVE HUNDRED PESOS (PHP 2,500.00) EACH, TO THE FORTY-EIGHT (48) SUPERVISORS OF THE MANILA HEALTH DEPARTMENT (MHD) AND APPROPRIATING THE AMOUNT NECESSARY THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. A monthly traveling allowance of TWO THOUSAND FIVE HUNDRED PESOS (Php 2,500.00) each, is hereby granted to the forty-eight (48) supervisors of the Manila Health Department.


SEC. 2. The amount of ONE MILLION FOUR HUNDRED FORTY THOUSAND PESOS (Php 1,440,000. 00) per annum, or so much thereof, as may be necessary, is hereby appropriated out of any unappropriated funds existing in the City Treasury to be made available for the implementation of this Ordinance.


SEC. 3. This Ordinance shall take effect upon its approval.


