ORDINANCE NO. <u>8038</u>

AN ORDINANCE AMENDING SECTION 2 OF ORDINANCE NO. 7868 BY INCREASING THE RATE OF MONTHLY FINANCIAL ASSISTANCE GRANTED TO PERSONNEL OF THE MANILA REGIONAL TRIAL COURT AND THE METROPOLITAN TRIAL COURT TO ONE THOUSAND PESOS (Php 1,000.00) A MONTH.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Section 2 of Ordinance No. 7868 is hereby amended to read as follows:

"Sec. 2. Pursuant to this policy, a monthly financial assistance of <u>One Thousand Pesos (Php 1,000.00)</u> each, is hereby granted to the Clerks of Court, Branch Clerks of Court and the rank-and-file employees of the Manila Regional Trial Court, and the Metropolitan Trial Court."

SEC. 2. The increase in the rate of financial assistance authorized in Sec. 1 hereof shall take effect January, 2002; *PROVIDED*, That the amount needed for the implementation of this Ordinance shall be charged against the appropriate expense account in the Executive Budget of the City of Manila for said year, subject to availability of funds and existing guidelines on the matter.

SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.
