

AN ORDINANCE PRESCRIBING A PROCEDURE FOR THE ELECTION OF OFFICERS OF THE LIGA NG MGA BARANGAY AND THE PANLUNGSOD NA PEDERASYON NG SANGGUNIANG KABATAAN IN THE CITY OF MANILA.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. There shall be an organization of all barangays represented by the Punong Barangay and the Sangguniang Kabataan Chairman in the Zone, District and City level for the purpose of determining their representation in the Liga ng mga Barangay and the Panlungsod na Pederasyon ng Sangguniang Kabataan.

SEC. 2. To ensure a just and equal representation for all the legislative district of Manila in the Liga ng mga Barangay and the Panlungsod na Pederasyon ng Sangguniang Kabataan, there is hereby created a Committee on Election which shall have the duty to formulate the procedures for the election of officers of the Liga ng mga Barangay and the Panlungsod na Pederasyon ng Sangguniang Kabataan without prejudice to the existing laws promulgated by the Commission on Elections and the Local Government Code.

SEC. 3. Representation Chapters. – Every Barangay shall be represented in the said Liga Chapters and Sangguniang Kabataan Chapters by the Punong Barangay and Sangguniang Kabataan or, in his absence or incapacity, by the kagawad duly elected for the purpose among its members, who shall attend all meetings or deliberations called by the different chapters of the Liga and SK Federation.

A. District Chapter

All elected Barangay Chairman in each District shall elect from among themselves the President, Vice-President and five (5) members of the Board. They shall appoint a Secretary and Treasurer and create such other positions as it may deem necessary for the management of the chapter. The duly elected President or his authorized representative duly elected for the purpose shall represent the District Chapter in the City Chapter of the Liga.

B. City Chapter

The District Chapter representatives shall automatically become members of the Board and they shall elect from among themselves a President, Vice-President, Secretary, Treasurer, Auditor and create other positions as it may deem necessary for the management of the chapter.

SEC. 4. The elected Presidents of the City Chapter, both in the Liga ng mga Barangay and the Sangguniang Kabataan, shall serve as the ex-officio members of the City Council and shall serve as such only during their term of office as, President of the City Chapter of the Liga and SK Federation, which in no case shall go beyond the term of office of the City Council.

SEC. 5. The date of election of representatives in each chapter shall be as follows.

- a. District Chapter 30 days after the Election of the Barangay
- b. City Chapter concurrent with the District Chapter election

SEC. 6. The Committee on Election shall supervise and implement the election of all Liga Chapters. *PROVIDED*, That any proclamation to be made by the Committee shall be appealable to the Department of Interior and Local Government (DILG).

SEC. 7. Repealing Clause. - All issuances and/or rules and regulations of parts thereof, inconsistent with the provisions of this Ordinance, are hereby repealed, amended or modified accordingly.


SEC. 8. Separability Clause. - If any provision or clause on section, or provision of this Ordinance is declared invalid or otherwise void ab initio, the other parts or provision or section which are not otherwise declared invalid void shall remain in full force and effect.


SEC. 9. Effectivity Clause. - This Ordinance shall take effect upon its approval.


