

ORDINANCE NO. 8044

AN ORDINANCE AMENDING SECTION 1 OF ORDINANCE NO. 7987 BY INCLUDING PUBLIC HEALTH WORKERS OF THE FOUR (4) CITY GOVERNMENT HOSPITALS NAMELY: THE OSPITAL NG MAYNILA MEDICAL CENTER, THE GAT ANDRES BONIFACIO MEMORIAL MEDICAL CENTER, THE OSPITAL NG SAMPALOC AND THE OSPITAL NG TONDO, IN THE IMPLEMENTATION OF RELEVANT PROVISIONS OF REPUBLIC ACT 7305, OTHERWISE KNOWN AS THE MAGNA CARTA OF PUBLIC HEALTH WORKERS, SO AS TO PROVIDE FOR RETIREMENT PAY, HAZARD ALLOWANCE, LONGEVITY PAY, AND OVERTIME PAY.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Section 1 of Ordinance No. 7987 is hereby amended to read as follows:


“SECTION 1. The implementation of relevant provisions of R.A. 7305, otherwise known as the Magna Carta of Public Health Workers, so as to provide for retirement pay, hazard allowance, longevity pay, and overtime pay of Public Health Workers in the Manila Health Department and the four (4) City Government hospitals namely: the Ospital ng Maynila Medical Center, the Gat Andres Bonifacio Memorial Medical Center, the Ospital ng Sampaloc and the Ospital ng Tondo, is hereby authorized.”

SEC. 2. Effectivity Clause. – This Ordinance shall take effect upon its approval.

Enacted by the City Council of Manila at its regular session today, July 30, 2002.




