

AN ORDINANCE WITHDRAWING FROM PUBLIC USE THE CERTAIN PARCEL OF LAND WITH AN AREA OF EIGHT HUNDRED (800) SQUARE METERS, MORE OR LESS, SITUATED ALONG CAVITE STREET FROM TINDALO TO JOSE ABAD SANTOS STREETS IN THE SECOND DISTRICT OF MANILA AND CONVERTING THE SAME AS PATRIMONIAL PROPERTY OF THE CITY, TO BE EXCLUSIVELY USED AS SCHOOL SITE OF THE MANUEL LUIS QUEZON HIGH SCHOOL.

Be it ordained by the City Council of Manila, THAT:


SECTION 1. That certain parcel of land with an area of eight hundred (800) square meters, more or less, situated along Cavite Street from Tindalo to Jose Abad Santos Street in the Second District of Manila and registered under the name of the City of Manila, is hereby withdrawn from public use and converted as patrimonial property of the City to be exclusively used as school site of the Manuel Luis Quezon High School.


SEC. 2. This Ordinance shall take effect upon approval.

Enacted by the City Council of Manila at its regular session today, December 7, 1999.




