## ORDINANCE NO. 8050

ORDINANCE CREATING THE POSITIONS FOR TEN (10) MEDICAL ANTECHNOLOGIST II (SG 15-1) AND FOR EIGHTEEN (18) LABORATORY AIDE II (SG 4-1), IN THE MANILA HEALTH DEPARTMENT, PURSUANT TO THE URBAN HEALTH AND NUTRITION PROJECT, UNDER THE MEMORANDUM OF AGREEMENT, AS AMENDED, IN ARTICLE 5, PARAGRAPH 5.1, LETTER (B) THEREOF, AMONG THE WORLD BANK, THE DEPARTMENT OF HEALTH, THE DEPARTMENT OF INTERIOR AND LOCAL GOVERNMENT AND THE CITY OF MANILA; AND APPROPRIATING THE NECESSARY FUNDS THEREFOR.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. Declaration of Policy. - It is hereby declared the policy of the City of Manila to continuously upgrade and improve the health and medical care and services released to its constituents as provided in Article II; Section 15, of the Philippine Constitution.

- SEC. 2. Pursuant to this policy, there is hereby created ten (10) positions of Medical Technologist II, with salary grade 15-1, and eighteen (18) positions of Laboratory Aide II, with salary grade 4-1, in the Manila Health Department.
- SEC. 3. The amount needed or so much thereof, as may be necessary, for the implementation of this Ordinance, is hereby appropriated out of any unappropriated funds existing in the City Treasury.

SEC. 4. This Ordinance shall take effect immediately upon approval.
