

AN ORDINANCE PROHIBITING THE OPERATION AND/OR DRIVING OF TRICYCLE OR PEDICAB FOR HIRE WITHOUT A HIGH TONE TOOTING HORN, SIGNAL LIGHTS, HEAD AND TAIL LIGHTS, IMPOSING THE APPROPRIATE PENALTY THEREOF AND FOR OTHER PURPOSES

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The penalty of ONE THOUSAND PESOS (Php 1,000 00) fine or imprisonment of one to ten days, or both such fine and imprisonment, shall be imposed on any person found driving or operating a tricycle or pedicab-for-hire, without a high tone tooting horn, signal lights, head and tail lights.


SEC. 2. This Ordinance shall, after approval, be incorporated in the New Traffic Code of Manila.


SEC. 3. Effectivity Clause. - This Ordinance shall take effect upon its approval.




