

ORDINANCE NO. 8062

AN ORDINANCE AUTHORIZING THE USE OF A PORTION OF LOT NO. 25-A, REGISTERED UNDER TRANSFER CERTIFICATE OF TITLE NO. 34872, MEASURING APPROXIMATELY ONE HUNDRED THIRTY TWO SQUARE METERS (132.0 SQ. M.) AS HEADQUARTERS OF THE BAMBANG, MASANGKAY, ABAD SANTOS VOLUNTEER FIRE BRIGADE UNDER CERTAIN CONDITIONS.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The use of a portion of Lot No. 25-A, covered by Transfer Certificate of Title No. 34872, measuring One Hundred Thirty Two Square Meters (132.0 Sq. M.), more or less, as headquarters of the Bambang, Masangkay, Abad Santos Volunteer Fire Brigade is hereby authorized.

SEC. 2. The plans and specifications for the construction of the building to be constructed on said lot shall be approved by the City Building Official of Manila.


SEC. 3. The authorization granted in Section 1 hereof, shall be deemed withdrawn/rescinded for violation of the provisions of this Ordinance.


SEC. 4. Effectivity Clause. - This Ordinance shall take effect upon its approval.
