

ORDINANCE NO. 8074

AN ORDINANCE AUTHORIZING THE CITY MAYOR TO ACQUIRE EITHER BY PURCHASE, OR EXPROPRIATION, A PARCEL OF LAND WITH AN AREA OF NINE HUNDRED NINETY THREE SQUARE METERS (993 SQ.M.), MORE OR LESS, COVERED BY TRANSFER CERTIFICATE OF TITLE NO. 166884, FOR AWARD OR RESALE TO ACTUAL AND BONA FIDE TENANTS THEREAT, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The City Mayor is hereby authorized to acquire, either by purchase, or expropriation, a parcel of land with an area of Nine Hundred Ninety Three Square Meters (993 Sq. M.), more or less, covered by Transfer Certificate of Title No. 166884, and registered in the name of the MAGPANTAY family, for award or resale to the actual and bona fide residents, tenants, occupants thereat, at the lowest possible price, under the Land-for-the-Landless Program of the City of Manila.

SEC. 2. The amount needed for the acquisition of said parcel of land, including expenses for filing of petition for expropriation shall be charged against the lump sum appropriation for acquisition of landed estates authorized in CY 2004 budget ordinance.


SEC. 3. The above undertaking shall be supervised by the City Housing and Urban Development Board, in coordination with the Urban Settlements Office with the direct and active participation of the We Are One (A. Rivera Street) Neighborhood Association, Inc., the Councilors representing the district and the barangay officials involved in planning and implementation.


SEC. 4. This Ordinance shall take effect upon its approval.
