ORDINANCE GRANTING A LEASE FOR FIFTY (50) YEARS TO THE IMMEDIATE FAMILY OF THE LATE PRESIDENT RAMON MAGSAYSAY ON THAT PIECE OF CITY LOT CONSISTING OF NINE HUNDRED SQUARE METERS (900 SQ.M.), LOCATED IN THE NORTH CEMETERY, WHERE THE REMAINS OF THE LATE PRESIDENT AND FORMER FIRST LADY, LUZ B. MAGSAYSAY ARE PRESENTLY INTERRED, AT THE NOMINAL RATE OF PHP 1.00 PER ANNUM.

Be it ordained by the City of Council of Manila, That:

SECTION 1. The lease of that piece of City Lot consisting of Nine Hundred Square Meters (900 Sq.M.) located in the North Cemetery where the remains of the late President Ramon Magsaysay and former First Lady Luz B. Magsaysay are presently interred is hereby authorized for a period of 50 years to the immediate family at the nominal rate of Php 1.00 per annum.

SEC. 2. This Ordinance shall take effect upon its approval.
