AN ORDINANCE TEMPORARILY WITHDRAWING FROM VEHICULAR USE THOSE PORTIONS OF DOS CASTILLAS STREET FROM MARIA CLARA STREET TO DIMASALANG STREET IN THE 3RD DISTRICT, AND FROM DIMASALANG STREET TO LAONG LAAN IN THE 4TH DISTRICT OF MANILA.

Be it ordained by the City Council of Manila, THAT:


SECTION 1. The temporary withdrawal from vehicular use of those portions of Dos Castillas Street from Maria Clara Street to Dimasalang Street in the 3rd District, and from Dimasalang Street in the 4th District of Manila is hereby authorized.


SEC. 2. Upon approval of this Ordinance, said stretch of Dos Castillas Street shall be converted into unloading and vending areas of flowers, and shall be known as "THE CUT FLOWER CENTER OF THE CITY OF MANILA" under the Pedestrianization Program of the City Government of Manila.


SEC. 3. *Effectivity Clause.* - This Ordinance shall take effect upon its approval.
