

ORDINANCE ALLOCATING A PORTION OF PARAISO NG BATANG MAYNILA LOCATED AT THE CORNER OF ADRIATICO STREET AND PRESIDENT QUIRINO AVENUE, MALATE, MANILA. AS SITE OF THE MONUMENT OF MARCELO H. DEL PILAR "PLARIDEL" AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The allocation of a portion of Paraiso ng Batang Maynila located at the corner of Adriatico St. and Pres. Quirino Ave. as site of the monument of Marcelo H. del Pilar "Plaridel" is hereby authorized.

SEC. 2. The City Mayor is authorized to cause the construction of a monument depicting a dynamic pose of Marcelo H. del Pilar.


SEC. 3. The expenses needed to finance this project shall be chargeable against the account "Other Infrastructure Projects" under the 20% Community Development Fund.


SEC. 4. This Ordinance shall take effect upon its approval.
