

ORDINANCE NO. 8100

AN ORDINANCE REQUIRING ALL OWNERS OF PET DOGS, OTHER CANINES OR PET ANIMALS TO ANNUALLY SUBMIT THEIR PETS FOR VACCINATION, IMPOSING PENALTY FOR VIOLATION THEREOF, AND FOR OTHER PURPOSES.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. All owners of pet dogs, other canines or pet animals shall hereby be required to annually submit their pets for vaccinations.

SEC. 2. The vaccination or inoculations of anti-rabies serum shall be administered by the City Veterinarian or his duly authorized representative from the Veterinary Inspection Board: *PROVIDED*, That a Certificate of Vaccination shall be issued therefor which shall state the date of vaccination and duration of effectivity which shall be for one (1) year only: *PROVIDED FURTHER*, That the payment of PhP 50.00 shall be made to the City Treasurer or his representative before the issuance of subject certificate: *PROVIDED FINALLY*, That owners of imported breeds shall be required to present a certification thereof issued by a private veterinarian.

SEC. 3. It shall be the duty of the City Veterinarian in coordination with the City Health Officer to periodically conduct a census of pet dogs in the City of Manila and organize a vaccination campaign in the barangays.

SEC. 4. Government owned hospitals in the City of Manila shall hereby be required to have a steady supply of anti-rabies serum.


SEC. 5. Penalty Clause. - Any person found violating or infringing this Ordinance, shall be punished by a fine of PhP 1,000.00 or 3 days imprisonment or both such fine and imprisonment at the discretion of the court.


SEC. 6. Effectivity Clause. - This Ordinance shall take effect upon its approval.


