ORDINANCE NO. 8105

AN ORDINANCE ADOPTING THE NATIONAL HEALTH INSURANCE PROGRAM OR REPUBLIC ACT NO. 7875 BY VIRTUE OF WHICH THE MAYOR HAD ENTERED INTO A MEMORANDUM OF AGREEMENT WITH THE PHILIPPINE HEALTH INSURANCE CORPORATION (PHILHEALTH).

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The City of Manila hereby adopts the National Health Insurance Program as well as its Implementing Rules and Regulations for In-Patient and Out-Patient services to cover indigent families of the City of Manila.

- SEC. 2. The Manila Health Department shall be the agency responsible for the implementation and monitoring of this Ordinance, and as such, shall fully coordinate with authorized officers or representatives of PhilHealth to effectively carry out the said National Health Insurance Program.
- SEC. 3. The Mayor of Manila, Honorable Jose L. Atienza, Jr., is hereby authorized to negotiate and enter into a memorandum of agreement with the Philippine Health Insurance Corporation and to sign for and in behalf of the City of Manila.

SEC. 4. This Ordinance shall take effect immediately upon approval.
