

AN ORDINANCE EXTENDING THE VALIDITY OF THE FRANCHISE GRANTED TO ABUCAY MARKET CORPORATION UNDER ORDINANCE NO. 7782 FOR ANOTHER TEN (10) YEARS RECKONED FROM THE DATE OF THE EXPIRATION OF THE ORIGINAL FRANCHISE UNDER TERMS AND CONDITIONS SET FORTH THEREIN

P R E A M B L E

WHEREAS, on 16 February 1993, the City Council of Manila passed Ordinance No. 7782, authorizing the Abucay Market Corporation, represented by its president, Ms. Cleotilde S. Flavier, to operate a wet and dry market at the corner of Abucay and Hermosa Streets, Manuguit Subdivision, Tondo, Manila;

WHEREAS, approved by His Honor, Mayor Jose L. Atienza, Jr., on 19 March 1993, the authority granted was for a period of ten (10) years from the date of approval as provided for in Section 2 thereof, such that the same expired in 2003 by operation of law: NOW, THEREFORE,

Be it ordained by the City Council of Manila, THAT:


SECTION 1. The validity of the franchise granted to Abucay Market Corporation under Ordinance No. 7782, is hereby extended for another ten (10) years reckoned from the date of the expiration of the original franchise under terms and conditions set forth therein: PROVIDED, That the Contract of Lease between the landowner and Ms. Cleotilde S. Flavier shall be submitted to the City Council for reference and record purposes.


SEC. 4. Effectivity Clause. - This Ordinance shall take effect upon its approval


