AN ORDINANCE WITHDRAWING FROM PUBLIC USE THAT ROAD AT TAYABAS STREET, TONDO, MANILA AND WITHIN THE JURISDICTION OF BARANGAY 231, ZONÉ 21, DISTRICT II, MANILA, WITH AN APPROXIMATE AREA OF ONE THOUSAND SEVEN HUNDRED TWELVE SQUARE METERS (1,712 SQ. M.), MORE OR LESS, FOR AWARD TO THE ACTUAL AND BONA FIDE MEMBERS OF THE NAGKAKAISANG SAMAHANG MGA WALANG LUPA TAYABAS, MANILA, INCORPORATED, UNDER THE LAND-FOR-THE-LANDLESS PROGRAM OF THE CITY OF MANILA.

Be it ordained by the City Council of Manila, THAT:

SECTION 1. That City road from Delos Reyes Street to Narra Street located at Tayabas Street, Tondo, Manila, with an approximate area consisting of One Thousand Seven Hundred Twelve Square Meters (1,712 sq. m.), more or less, adjacent to the De Guia Estate, in Barangay 231, Zone 21, in the 2nd District, is hereby withdrawn from public use for award to the actual and bona fide members of the Nagkakaisang Samahang Mga Walang Lupa Tayabas, Manila, Incorporated, under the Land-for-the-Landless Program of the City of Manila.

SEC. 3. For proper implementation of this Ordinance, the following shall be duly considered, to wit:

- A public hearing should be conducted for a full evaluation of the lot owners' position on the matter, its feasibility and the 1. determination of the due compensation;
- A meeting with the respective government agencies or offices in order to ensure their full cooperation for the proper 2. implementation of this Ordinance and for them to give their comments and endorsements on the subject matter;
- The matter of availability of funds be properly addressed prior to approval of this draft ordinance, to find out whether or not the 3. implementation of the proposed ordinance is practicable and viable, so as not to give false hopes to those who have been longing to benefit from this Ordinance. And of course, equally important is the verification if indeed the subject parcel of land is owned by the City of Manila, as this will affect the budgetary requirement for its implementation.

SEC. 4. Effectivity Clause. - This Ordinance shall take effect upon its approval.
