

AN ORDINANCE EXEMPTING DULY LICENSED MEAT SHOPS/MEAT DEALERS LOCATED IN SUPERMARKETS AND GROCERIES FROM THE COVERAGE OF ORDINANCE NO. 3782, UNDER CERTAIN CONDITION.

Be it ordained by the City Council of Manila, THAT:

SECTION 1: Duly licensed meat shops/meat dealers located in supermarkets and groceries selling or offering for sale fresh meat to the public are hereby exempted from the coverage of Ordinance No. 3782; *PROVIDED*, That such meat is duly marked and accompanied by a meat inspection certificate issued by a Veterinarian from the Veterinary Inspection Board attesting that the animals furnishing the meat have undergone anti-mortem and post-mortem examinations and found fit for human consumption.


SEC. 2. All Ordinances or parts thereof which are inconsistent with the provisions of this Ordinance are hereby modified and/or amended accordingly.


SEC. 3. Effectivity Clause. – This Ordinance shall take effect upon its approval.
