ORDINANCE NO. 8121

AN ORDINANCE INCREASING THE MONTHLY INCENTIVES/TRANSPORTATION ALLOWANCE FOR SUPERVISORS OF THE DEPARTMENT OF EDUCATION (DEP-ED), MANILA FROM SIX HUNDRED PESOS (PhP 600.00) TO ONE THOUSAND PESOS (PhP 1,000.00).

PREAMBLE

WHEREAS, the Dep-Ed Manila supervisors are respected as educational leaders and innovators and are considered as experts/consultants by their peers in the Dep-Ed NCR and the Department of Education;

WHEREAS, thus, in 1990, public school supervisors of Manila were granted by the City Government incentives/transportation allowance;

WHEREAS, there were 100 supervisors then who started receiving PhP 600.00 per month, but this number was reduced to 27;

WHEREAS, thus, from the original budget of PhP 60,000.00 per month for 100 supervisors, it is now only PhP 16,200.00 per month for the 27 supervisors;

WHEREAS, the previous supervisors then were in charge of only two districts each, but presently almost all of them supervise all schools in the six districts of Manila, with some of them supervising both elementary and secondary teachers;

WHEREAS, the minimum fare for public transport then was only PhP 2.00 but now, it has risen to PhP 7.50 and is expected to increase again, however, in certain instances these supervisors are forced to take taxicabs in order to avoid Manila's traffic gridlocks just so that they can be on time in attending to important functions in schools or in the Dep-Ed NCR which is located in Pasig City;

WHEREAS, moreover, these supervisors are in a way exposed to various risks and hazards to their school destination to discharge their duties and functions while traveling: NOW, THEREFORE

Be it ordained by the City Council of Manila, THAT:

SECTION 1. The monthly incentive/transportation allowance for supervisors of Department of Education-Manila shall hereby be increased from SIX HUNDRED PESOS (PhP 600.00) to ONE THOUSAND PESOS (PhP 1,000.00).

SEC 2. Effectivity Clause. - This Ordinance shall take effect upon its approval.
